**PLAINTIFF'S MOTION TO
CONTINUE (RESCHEDULE) THE

16 Plaintiff AF Holdings, L.L.C. ("Plaintiff"), through its undersigned counsel, hereby moves
17 this Honorable Court to continue (reschedule) the Show Cause Hearing which is currently scheduled
18 for May 31, 2013, at 2:30 p.m., and in support of this motion, states as follows:

19 1. In its Order of May 17, 2013 (ECF No. 51), this Court ordered that Plaintiff show
20 cause within seven (7) days why this Court should not dismiss this case; and set a Show Cause
21 Hearing for May 31, 2013 at 02:30 PM.

22 2. Plaintiff's counsel is currently scheduled to appear in Weld County District Court in

6 5. Additionally, Plaintiff intends to have representatives and/or witnesses attend the
7 Show Cause Hearing, who will be traveling from out of state, and require additional time to make
8 the necessary plans and travel arrangements to appear.

9 6. Plaintiff will comply with the Court's Order and file a response to the Show Cause
10 Order in a timely manner.

11 7. On May 20, 2013 and May 21, 2013, Plaintiff's counsel conferred with Counsel for
12 Defendant John Doe and Defendant David Harris, respectively, about the Motion to Continue the
13 Show Cause Hearing. Neither counsel for Defendant John Doe, nor Defendant Harris expressed any
14 objection to the granting of the continuance.

15 8. Wherefore, Plaintiff respectfully requests an Order of this Court continuing
16 (rescheduling) the Show Cause Hearing currently set for May 31, 2013.
